## TERMS OF REFERENCE

### PROVISION OF BUSINESS INTELLIGENCE AND FINANCIAL REPORTING SOLUTION

#### 1. BACKGROUND

The National Electronic Media Institute of South Africa (NEMISA) was established as a non-profit educational institute in terms of the Companies Act (1973) and is listed as a Schedule 3A public entity under the Public Finance Management Act (PFMA), 1999.

NEMISA derives its mandate from the Department of Communications and Digital Technologies (DCDT). In line with its strategic objectives, the Institute seeks to strengthen evidence-based decision-making, enhance governance, and improve financial performance through a robust Business Intelligence (BI) and Financial Reporting Solution.

#### 2. PURPOSE

The purpose of this Terms of Reference (TOR) is to procure a **Business Intelligence and Financial Reporting Solution** that automates financial reporting, provides integrated dashboards, and enables real-time analysis across multiple systems. The solution must simplify data management, enhance reporting accuracy, and support data-driven decision-making across all functional areas of NEMISA.

#### 3. OBJECTIVES

The primary objectives of the solution are to: - Automate financial and performance reports in alignment with PFMA and Treasury reporting frameworks. - Integrate seamlessly with existing financial systems (Sage, Caseware, and Greenfield). - Provide interactive dashboards for management and executive oversight. - Enable advanced analytics and predictive insights for strategic decision-making. - Improve operational efficiency and data governance.

#### 4. INSTRUCTIONS TO BIDDERS

- Bidders must submit full proposals in **PDF format** via email by the closing date indicated in the Request for Quotation (RFQ) cover page.
- Attendance at a **compulsory briefing session** and **system demonstration** is mandatory.
