TERMS OF REFERENCE (TOR)

SOURCING OF A SERVICE PROVIDER TO PROVIDE RISK MANAGEMENT TRAINING TO NEMISA MANAGEMENT AND EMPLOYEES

1. BACKGROUND

NEMISA is a national public entity listed under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008.

2. PURPOSE

2.1 NEMISA requires the services of the external service provider to provide comprehensive training for the Risk Management Unit as outlined under section 2 of this ToR to NEMISA and various relevant role players within the risk management process as guided by National Treasury risk management roles and responsibilities (i.e., Accounting Authority, Accounting Officer, Management, ERMCO Members, Risk Champions, Chief Risk officer and other Employees).

2.2 The total number of 60 trainees is broken down as follows:

- Management (EXCO / ERMCO / Management)
- Risk Champions
- Other Officials/Employees

3. SCOPE OF WORK

- 3.1. The service provider(s) shall render and be responsible for the required training to NEMISA Management and Employees as indicated in 2.2 above.
- 3.2. The training must align to and be based on the relevant risk management legislative requirement, Risk Management Frameworks, and international best practices, i.e. National

Treasury Risk Management Framework, Treasury Regulation, KING IV Report, ISO 31000, COSO amongst others.

- 3.3. The learning content must enhance the risk culture for NEMISA and aim to improve the NEMISA risk maturity level.
- 3.4. The training must empower NEMISA employees to carry out their risk management roles and responsibilities.
- 3.5. The training must take into account typical challenges faced by the risk unit in entrenching organisational excellence in risk management and how those can be overcome
- 3.6. The training must be practical, engaging, supported by case studies and participatory including quizzes or learner assessments
- 3.7. The training content must be agreed upon before the training and must include the following to ensure it is specific to NEMISA's needs:

3.7.1. MANAGEMENT TRAINING

Provide Enterprise-Wide Risk Management training to NEMISA Staff

- ❖ The training must align to and be based on the relevant risk management legislative requirement, Risk Management Frameworks, and international best practices, i.e., National Treasury Risk Management Framework, Treasury Regulation, KING IV Report, ISO 31000, COSO, amongst others.
- ❖ The training must enhance the risk culture within NEMISA, and aim to improve the NEMISA risk maturity level
- ❖ At the end of the training employees must:
 - ✓ Understanding the Risk management framework and strategies

 - ✓ Integrating risk management into daily operations planning, budgeting, decision making, and performance management.
 - ✓ Be able to conduct a basic risk assessment and develop a risk register with risk treatment plans.

3.7.2. ROLES OF RISK & COMPLIANCE CHAMPIONS

The objective is to provide practical customised risk champions training. The training must cover an introduction to risk management to NEMISA risk champions to empower them to understand their roles and expectations as they relate to the NEMISA's environment.

These interactive sessions should involve various identification and assessment exercises customised to NEMISA's risk Frameworks, Policies, and Methodologies.

The training should include the foundations of risk management and not be limited to the following:

- ❖ Enterprise Risk Management and practical guidance for the application of methodologies for undertaking the required risk management activities such as Risk Assessments, Control Assessments, and Risk Management Reporting
- ❖ Communicating why the organisations is focused on risk management, the benefits of the program, and the resources dedicated to it.
- ❖ Empower the Risk Champions in discharging their responsibility for risk management
- ❖ Provide the Risk Champions with information to enable them to fully understand the roles and responsibilities of their office in terms of risk management.
- ❖ Understand what is risk.
- ❖ Understand what risk management is.
- ❖ Risk management legislative frameworks
- ❖ How do we identify, assess, record, and manage risk
- ❖ Practical application of NEMISA risk appetite and tolerance
- ❖ What is the organisation's current risk appetite?
- ❖ How do to communicate risks and the reporting requirements
- ❖ How to facilitate risk identification within their units and risk conversations.
- ❖ What tools are available for risk management?

Compliance:

- ❖ Empower the compliance champions to perform compliance champion roles in addition to their day-to-day roles and enable them to operate as a link between the compliance unit and the wider business.
- ❖ Empower them on how to identify compliance issues and how to help their own teams report and mitigate non-compliance issues that may arise.
- ❖ Enable champions to identify gaps in knowledge to enable tailored training for different areas.
- ❖ Empower them to be ambassadors for the compliance unit to spread messaging to different areas peer to peer and in a common language.

Ethics:

The training must aim to enhance the fraud risk management and fraud prevention and awareness culture across NEMISA.

The training must align to and be based on the related relevant fraud prevention strategies, Acts, legislative requirements and best practices, and not limited to, i.e., National Treasury Regulations, PFMA, PRECCA Act 12 of 2000, and Public Service Anti-Corruption Strategy.

The training content should be tailored to cover NEMISA's requirements and must at least cover but not be limited to the following Topics:

- ❖ Enhance NEMISA's fraud prevention and awareness strategies.
- ❖ Introduction to ethics and ethics-related concepts
- ❖ Ethics and Integrity management
- ❖ Ethics awareness and ethical decision-making
- ❖ Ethical leadership
- ❖ Behavioural ethics
- ❖ Ethical culture and conduct
- ❖ Conflicts of Interest and the best practice guidelines and legislative requirements for declaring and managing conflicts of interest
- ❖ Defining conflicts of interest
- ❖ Types of conflicts of interest
- ❖ Regulatory framework surrounding conflicts of interest.

- ❖ Managing conflicts of interest

4. COMPETENCY AND EXPERIENCE REQUIREMENTS

1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS

1.3 PRICE AND SCM EVALUATION CRITERIA

- 1.3.1 All remaining bids will be evaluated as follows:

- 1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .
- 1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower scoring bid on justifiable grounds.
- 1.4 ADJUDICATION OF BID**
- 1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
